## What is an Endowment Fund?

The Endowment Fund is a means by which special gifts of members, friends of the congregation, organizations, corporations, etc. can be received and distributed to extend the programs and ministries of Faith Lutheran Church, Bloomington, Indiana.

The Fund is a separate fund from the weekly contributions which support the regular budgetary needs of the church. The Fund is not intended to interfere with or supplement the regular stewardship or other programs of the church.

## Purpose

The Endowment Fund's purpose shall be to further the mission and ministry of Faith Lutheran Church and its ministries, including, but not limited to Faith Lutheran Preschool and Christian Child Care program, missions and missionaries, and recognized service organizations (RSOs) of The Lutheran Church--Missouri Synod (LCMS).

## Fund Operation

The Endowment Fund enhances the mission of Faith Lutheran Church apart from the general operations of the congregation. The Endowment Fund generates an ongoing source of income, enabling the congregation to expand and continue a vision of stewardship and support for responding to important needs and new ministry opportunities.

## Partnership with LCMS Foundation

The LCMS Foundation manages the investments of the Fund's gifts. This partnership allows Faith Lutheran to focus on ministry needs and provide the best opportunities for stewardship and long-term ministry growth.

The Foundation provides charitable gift administration to help donors:

- learn about planned giving opportunities to support the fund
- create a gift plan unique to their lives and circumstances



## Fund Accounts

Individuals who desire to support the Fund should designate their gift to *The Endowment Fund of Faith Lutheran Church, Bloomington, Indiana*. Gifts may be deposited in one or more of these accounts.

### Unrestricted Account (URA)

- no minimum gift amount
- includes all undesignated gifts and bequests
- used to support many ministry opportunities at Faith Lutheran

### Congregational Restricted Accounts (CRA)

- no minimum gift amount
- Focused on certain ministry categories (Please contact the Endowment Committee for a list of these categories.)

### Donor Restricted Account(s) (DRA)

- \$100,000 minimum initial contribution.
- Gifts and bequests may be given by the donor with special terms or conditions as to the use of the gift. (The gift and conditions will require acceptance by the leadership and voting members of Faith Lutheran.)
